1. Period of evaluation

Remote evaluation: July 2017 – End of August 2017

Peer review meeting: 2 presence days, 18-19 September 2017 in Brussels, BE

2. EMEurope Call 2016 in brief

In collaboration with the European Commission and the European Green Vehicles Initiative Association, European countries and regions set up the Electric Mobility Europe Call 2016 (EMEurope Call 2016) to further promote and advance electric mobility in Europe. Funded projects in the EMEurope Call 2016 shall focus on the application and implementation of e-mobility in urban and suburban areas.

In the EMEurope Call 2016 14 countries and regions and the European Commission are providing research funds totalling some 23,000,000 EUR for coordinated funding of Research & Innovation projects.

The EMEurope Call 2016 will support Research & Innovation projects addressing the following 5 Key Areas of electric mobility:

1. System integration (transport, urban and sub-urban areas);
2. Integration of urban freight and city logistics in e-mobility;
3. Smart Mobility concepts and ICT applications;
4. Public Transport;
5. Consumer behaviour and societal trends.

The transnational call is open for applicants from the countries and regions providing funding to the EMEurope Call 2016: Austria, Belarus, Denmark, Finland, Germany, Hungary, Israel, Italy-Piedmont Region, the Netherlands, Poland, Spain-Catalonia Region, Spain, Sweden and Turkey.

3. Evaluation process and timeline

The evaluation of the EMEurope Call 2016 proposals will be carried out in 2 steps:

1. Evaluation by delegated national and regional experts – light proposals
2. Evaluation by international peer-review – full proposals

The 1st step was carried out by the involved national funding organisations and resulted in a short list of proposals that have been invited for preparation of a full proposal. The deadline for submission of full proposals is 09 June 2017.

The 2nd step evaluation comprises the quality assessment of full proposals and will be carried out by independent international experts. The evaluation period is July 2017 until end of August 2017, involving a remote evaluation period and a 2-day peer review meeting in September 2017.

Detailed information on the evaluation procedure will be available for the selected experts.

4. Experts profiles

EMEurope is now looking for independent, international experts for the quality assessment of full proposals.

Experts should have expertise in, know-how and knowledge of one or more of the five Key Areas of the EMEurope Call 2016.

Furthermore, they have to be independent from the involved funding organisations of the EMEurope Call 2016 and be free of any conflict of interest with the proposals to be evaluated.

Experts will not be allowed to delegate the work to another person.

Finally they have to be available for:

1. Remote evaluation by means of email and the web-based Call Management Tool (CMT) (estimation: 3 proposals for each expert, and 0.5 day for each proposal)
2. Attendance at a 2-day peer review meeting, 18-19 September 2017, in Brussels, Belgium. This meeting will cover:
 - a. Panel evaluations of submitted proposals on the basis of the written evaluation reports
 - b. Plenary session with the compilation of all results for validation
 - c. Provision of one ranking list of full proposals.

The ranking list of full proposals will be put forward for the funding decisions of the national programmes, which will result in a selection list.

5. Reimbursement

Remote evaluation

- It is expected that each expert will evaluate 3 proposals (minimum 1, maximum 8) and that reading and assessing one proposal will take 0.5 day

Peer review meeting

- Travel and accommodations costs and subsistence allowance
- 2 days presence in Brussels, Belgium, on 18 and 19 September 2017

The reimbursement for labour amounts to 225 EURO per 0.5 day (in line with reimbursement for experts in Horizon 2020). As an example, taking into account the evaluation of 3 proposals it would amount to a total reimbursement of 1575 EURO (plus travel and accommodation costs and subsistence allowance).
